#### 1. Charlesworth.CPA

Our new website will let you and potential new clients know more about us and our procedures. It has a "Client Portal" tab with a direct link to easier login to SmartVault. The Resources page has a list of what to bring for your tax prep, situations when you should call us throughout the year and links to numerous tax and financial resources including short videos. A link to The Pennsy Depot **Banquet Room** on the Room Rental tab. Our Tax Clients will receive a reduced rate on bookings.

- 2. For new clients, we have an Electronic Fact Gathering sheet to easily send us basic information. Tell your referrals to see "New Clients Start Here" on the Charlesworth.CPA website.
- 3. In the past, this mailing would include an Engagement Letter and Questionnaire. The Resources page of the website contains a link for the Engagement Letter with a few questions. Watch your email for a link.
- **4. DocuSign** is a paperless way to sign your income tax releases to electronically file if you do not print, scan, sign and upload forms.

- be reviewed, printed and shared from your secure **SmartVault** account. Our website gives instructions for a SmartVault **iPhone** app as well as Android info and how to take a picture of your documents, convert to a .pdf file (preferred) and send to us.
- **6.** We are trying to save trees! Your **Organizer** can be found in **TY20** (tax year) of your secure **SmartVault**.
- **7.** Payments for our tax prep services can be made online in a variety of ways.
- **8.** In just a few short days, with new methods developing daily, we readied our staff for remote working. New technology was implemented in the fall to make this simpler and secure.
- **9.** Our processing room now has cabinet storage and larger workspace for processing returns. We try and utilize clients whenever possible.
- **10.** Clients can now **text** us at **219-733-2039.** Although we prefer your documents be uploaded directly to your SmartVault account, you may send us info via text.

# Do you need a paper copy of your return?

It has been said that during the first two months of lockdown, Americans leaped forward five years in their use of technology. We believe that to be true. Many new users of SmartVault really liked its ease of use. As this goes to print, we still have more than 40 2019 printed returns in our office that are paid, signed electronically and filed. With our portal, everyone has access to their return, but also scanned source documents 24/7. No more bulky paper to be filed. You can also copy the pdf directly to your own computer or securely share it with bankers, lawyers, etc. On the **Engagement Letter Ques**tionnaire, please answer NO if an electronic copy of your return is enough and a paper copy is not necessary.

To better serve all clients, our Valpo office has set hours (see front) and is accessible. Wanatah clients may continue to drop info in the front porch box as in the past. However, clients will be notified and may pick up returns (if a paper copy is sought) at their own convenience at our Valpo office at the corner of Sturdy Road and Comeford Road, south of US 30.



STAPLE any documents together or to the organizer. Please remove tax documents from the envelopes, recycle envelopes and fillers.

Using your 2019 income tax return as a guide, gather pertinent tax papers for 2020, add any additional or new information, and upload the information to our portal, mail or drop off your tax documents.

If information is received after March 10, it may be necessary to put your return on extension.

Social distancing and masks are required in our office. In order to keep our staff and clients safe, we are kindly asking that the engagement letter and questions be filled out in advance and drop offs be brief. Watch you email for the engagement letter link.

If you would like to have curbside service, please call us when you are in the parking lot and we would be happy to run out.

Clients that have the ability to sign efile forms and pay electronically before coming to our office for paper return pick ups are appreciated.

#### **Income Tax Update**

This Chronicle can't begin to list changes brought on by the pandemic, CARES Act and more. Briefly, many taxpayers received an Economic Impact Payment (stimulus check). It is NOT taxable, however, we do need to know the amount received to reconcile it on your return. Another highlight is the above the line donation deduction for 2020 is extended into 2021. Let us know if you made charitable contributions of up to \$300 single, \$600 joint. You'll want to do that in 2021 as well. We tried to let clients know updates via email and Facebook. We will continue to do so in the future.

SmartVault is an online platform for managing and securely sharing files and all clients are encouraged to use it. It can easily and securely be accessed from the **Charlesworth.CPA Client**Portal page. You may upload your 2020 documents as well as view and print your 2017 - 2020 income tax returns and source documents.
